Updates:

Human Resources:

Joey Evans

- Gender Transition will be removed as an exclusion from UNM health care plans effective July 1, 2017.
- UNM's life insurance provider, The Standard, is moving to an in-house web platform effective June 1, 2017. Employees may notice some difference in the look and feel, but all the date (i.e. beneficiaries, etc.) should migrate correctly.

Brenda De La Pena

- Open Enrollment for health care, vision, and dental plans as well as opt-out for VEBA ends on May 12th.
- No update on status of Leave Accrual change (postponed until 2018).
- Consumer Driven Health Care (High Deductible) and Health Savings Accounts (HSAs), per Fran, will be taken up again in the fall (when the faculty are back).
 - O Aon confirmed it us not typical to collect HDHP implementation stats around how many employees do not embrace the plan once enrolled. For example, capturing how many individuals enroll in an HDHP and then request to change enrollment after starting. (One committee member's question during the March meeting.)
 - o **Action Reminder:** Committee members should email Brenda their questions regarding the High Deductible Health Plan over the summer and she will create a draft response to the questions. Fran encouraged all committee members to participate.
