## Changes Affecting Other Departmental Programs

As a result of New Mexico Senate Bill 329, passed by the New Mexico Legislature in the 2015 Session, all teacher preparation programs in the College of Education are altering their curricula in order to comply with the new legislation.

The College of Education created the Curriculum Consensus Committee (CCC) to discuss the program revisions necessary in all Teacher Preparation Programs in the College in response to Senate Bill 329. These Teacher Preparation Programs are housed in the following Departments:

Individual Family and Community Education
Teacher Education, Educational Leadership \& Policy
Teacher Education, Educational Leadership \& Policy
Educational Specialties
Health, Exercise, \& Sports Sciences
Language, Literacy, \& Sociocultural Studies

Program:
Early Childhood Multicultural Education
Elementary Education
Secondary Education
Special Education
Physical Education
Bilingual \& TESOL Endorsements

The CCC, with members representing each of the above programs and departments, has been meeting since August 2015 to jointly revise these programs and arrive at consensus on these proposed changes. The proposal for program changes in this Form C reflects agreements among all teacher preparation program faculty in the College of Education.

In order for this Form C to reach the Undergraduate Committee, it must have been voted on by the Program Faculty, Department Faculty, College of Education Undergraduate Committee, and College of Education Faculty.
In addition, representatives from the Dean's Office have met with faculty and/or Chairs from the College of Arts and Sciences and the College of Fine Arts, whose departments are affected by these changes.

Changes Affecting Branch Campuses
With these proposed changes, curricula at Branch Campuses will not be affected. Additional conversations will be held to develop clearer lines of transfer and advising communication between the College of Education and UNM Branch Campuses.

## Justification for the Program

This Form C does not represent a new program, but provides details for a revision to the current BSED Degree with a major in our education programs.

As justification, these revised program changes are proposed as a result of New Mexico Senate Bill 329 , passed by the New Mexico Legislature in the 2015 Session. All teacher preparation programs in the College of Education are altering their curricula in order to comply with the new legislation. New program plans must be in place and approved by the New Mexico Public Education Department (NM PED) by July 1, 2016. These changes must be reflected in the UNM Catalog for incoming freshmen for the Fall 2016 semester.

As teacher licensure preparation programs, we are bound by certain New Mexico legislative statutes. We are required by state law to revise our program requirements as a result of SB 329.

## Impact on Long-Range Planning:

These program changes are a part of our long-range planning when possible to enable students to earn the BSED Degree within the University's 120 credit hour goal. Enabling students to graduate with 120 hours will allow us to better recruit and retain students.

## Detailed Budget Analysis

To date, no detailed budget analysis has been conducted, due to the brief time period we have to comply with SB 329. New courses are being created in College of Education Programs; however, they are replacing existing courses. In addition, by being able to recruit students to our programs
with a plan for them to graduate in 120 hours, we believe we will increase our enrollments, student credit hour production, and graduation rates. No matter what the budgetary implications, we are bound by New Mexico State Law to revise our program to comply with SB 329.

## Faculty Workload Implications

Currently faculty, along with part-time instructors, deliver the coursework in the teacher preparation programs. We will continue this practice as we implement these program changes. We anticipate that faculty workload will not be increased because new courses are replacing existing ones within the Program. Currently, faculty in the College of Education teach under a $3 / 2$ load; however, more part-time instructors and tenure and tenure-track faculty may need to be hired as our enrollment increases over time.
