There is an urgent need to align the curriculum for undergraduate degrees currently listed as leading to Secondary Education Bachelors programs with the university curricular and Banner systems. The current B.A. Ed in Communicative Arts Education was enacted years ago when current content teaching fields (endorsements in the New Mexico licensure system) were implemented in the university to align with state endorsement requirements. Because of implementation in 2004 of the university curriculum terminology alignment project that has instituted academic terminology (rather than state licensure terms), the system can no longer accommodate these teaching fields for the Secondary Education Undergraduate Programs in the same format as before. Likewise, the new format can no longer provide access to the Secondary Education Program (for students or faculty) or reports within the university Banner system. The current B.A. Ed. in Communicative Arts Education is not aligned with university terminology or the Banner System because it names a teaching field (state licensure term) rather than a major. The deletion of this teaching field will be replaced with the Secondary Education Major (B.A. Ed. in Secondary Education) proposed in the Form C which accompanies this proposal. A new Concentration-Teaching Field in Communicative Arts Education will meet university terminology requirements and have designated codes that will be recognized in the Banner System.

All students must complete application and be admitted prior to beginning the program. Admissions are competitive and limited by capacity to deliver a quality program. Undergraduate Curriculum for Students Preparing to Teach in Secondary Schools

The Secondary Education curriculum leading to the Bachelor's Degree (B.A. Ed. and B.S. Ed.) is designed for students preparing to teach in middle schools, junior high schools or senior high schools (grades 7-12). A faculty advisor in the Secondary Education Program must approve students' advisement sheets. The advisement sheet for the Secondary Education major and licensure has three components:

- a. General Education Requirements
- b. Secondary Education Concentration Teaching Field Requirements
- c. Secondary Education Major Requirements

General Education Requirements (66 hours)

- Communication Arts (12 hours) ENGL 101, ENGL 102, LING 101, C&J 130 or 220.
- 2. Mathematics (6 hours) MATH 120, STAT 145.

3. Science (12 hours)

Select from BIOL 110 and 112L, 201, 202 and 203 CHEM 111L, 121L or 131L, 122L or 132L; EPS 101 and 105L, 201L; ENVS 101:PHYC 102-102L, 151-152:. 160-160L, 161-161L; ASTR 101.

4. History (12 hours)

HIST 101L or 102L, 161L, 162, 260 or 463.

5. Social Science (6 hours)

Sect from SOC 101, PSY 105, POLS 110 or 220, ANTH 101 or 130, ECON 105 or 106, or GEOG 102.

6. Fine Arts (6 hours)

ARTH 101 or 251, MUS 139 or 140.

7. Second Language (3 hours)

Select from any of the lower-division, non-English language offerings of the Departments of Linguistics, Spanish and Portuguese, and Foreign Languages and Literature.

Secondary Education Concentration—Teaching Field Requirements

In New Mexico, teachers must complete one or more teaching fields (endorsements) to apply for a Secondary Teaching License (grades 7-12). The Concentration—Teaching Fields included within the B.A.Ed. and the B.S.Ed. in Secondary Education degrees meet the state teaching field (endorsement) requirements for licensure: 54 hours for a composite teaching field; 24-36 hours for a single subject teaching field; at least 12 hours at the 300 level or above in both types of teaching fields. See advisement sheets for specific details in each concentration-teaching field. Please contact at the Advisement Center or go to the website (http://cte-0027.unm.edu).

The B.A. Ed. in Secondary Education includes at least one of the following concentration-teaching fields:

Teaching Field - Communicative Arts Composite (54 hours): This composite teaching field includes interdisciplinary study in literature, writing, communication and journalism, and theatre arts.

Teaching Fields - Modern and Classical Languages (30 hours): These teaching fields requires course work in ONE of the modern and classical languages available for secondary licensure (French, German, Spanish) that enable students to develop proficiencies in the varied aspects of their chosen language, including oral and written communication skills, grammar, literature and culture.

Teaching Field - Social Studies Composite (54 hours): This teaching field includes interdisciplinary study in social studies including history (U.S. and Western Civilization), political science, anthropology, economics, geography, economics and sociology.

The B.S. Ed. in Secondary Education includes at least one of the following concentration-teaching fields:

Teaching Field - Mathematics (34 hours): This teaching field requires mathematics courses that enable students to develop proficiencies in calculus, algebra, geometry, probability and statistics, computing, application of mathematics and history of mathematics.

Teaching Field - Science Composite (54 hours): The composite teaching field in science consists of course work in the broad fields of science and mathematics. Four areas of concentration are available:

- Physical Science (Physics Emphasis). This area of concentration requires 30
 Hours in chemistry and eight hours EACH in biology, earth and planetary sciences, physics
 and mathematics.
- 2. Physical Science (Chemistry Emphasis). This area of concentration requires 30 hours in chemistry and eight hours EACH in biology, earth and planetary sciences, physics and mathematics.
- 3. Earth Science. This area of concentration requires 30 hours of earth and planetary sciences and eight hours EACH in biology, chemistry, physics and mathematics.
- 3. Life Science. This area of concentration requires 30 hours of biology and eight hours EACH in earth and planetary sciences, chemistry, physics and mathematics.

Other Content Areas/Endorsement Programs of Studies Available for Secondary Education Majors

Interested Secondary Education students may elect to pursue programs of studies in other content areas that meet K-12 licensure and/or endorsement requirements in addition to a Secondary Education Concentration-Teaching Field. For more information, contact the appropriate programs.

Visual Art Licensure: The College of Education offers course work towards a Visual Art Licensure K-12. Those interested should see the section on Art Education in this Catalog and contact a program advisor.

Bilingual Education (24 hours): Students may elect to pursue a New Mexico K-12 endorsement in Bilingual Education with either a Spanish/English or Navajo-English focus. See a Bilingual Education Program advisor in the Department of Language, Literacy and Sociocultural Studies for current information about the Bilingual Education Endorsement requirements.

Fine Arts (36 hours): The Fine Arts Endorsement program of studies focuses on one of two areas: **Theatre:** This teaching field requires 36 hours of courses that cover all aspects of theatre including acting, voice, directing, stagecraft, theatre history and script analysis, and is designed to qualify a person to teach drama courses and direct school plays at the secondary level.

Dance: This teaching field requires 14 hours in dance technique (modern, ballet, ethnic, folk, jazz and tap) and 22 hours in dance appreciation, improvisation, rhythmic fundamentals, movement analysis, choreography and musical structure, dance history and dance curriculum development.

Specific Theatre and Dance course requirements are listed in the Department of Theatre and Dance section of this Catalog. Requirements may change. See the Theatre and Dance advisor for current information.

Reading (24 hours): This program of studies provides advanced study in the teaching of reading for a New Mexico K-12 endorsement. See a Literacy Program advisor in the Department of Language, Literacy and Sociocultural Studies for current information about the Reading Endorsement requirements.

Teaching English to Speakers of Other Languages (36 hours): Students may elect to pursue an K-12 endorsement in Teaching English to Speakers of Other Languages (TESOL). See a TESOL Program advisor in the Department of Language, Literacy and Sociocultural Studies for current information about the TESOL Endorsement requirements.

Secondary Education Major Requirements (27 hours)

The following professional education sequence is required of all undergraduate students working towards a secondary education major and eligibility for a secondary initial teaching license. In order to qualify for Teaching Experience I and Student Teaching course work, students should complete the general education and concentration-teaching field requirements. However, if space is available and other requirements have been met, students may be allowed to proceed into the professional education sequence if lacking no more that six hours total of the general education and/or teaching field course requirements. Students must achieve and maintain a "B" or better average overall in required education courses in order to advance to Student Teaching. The Teaching Experience I and Student Teaching courses require a field experience in a secondary school. Students should be prepared to spend time in schools during both fall and spring semesters. Student Teaching requires full-time teaching for at least **one public school semester**. A total of 12 credit hours are required for this experience, which includes Student Teaching (9 hours) and the Student Teaching Seminar (3 hours). The Student Teaching courses follow the public school (rather than the University of New Mexico) calendar.

Altogether, completing the secondary education major will take from two to three semesters. Students are urged to consult the College Advisement Center and faculty advisors as early in their college careers as possible.

NOTE: Changes in UNM/state curricular requirements or state reform initiatives in education may require periodic revisions of the curriculum and admissions process.
