Justification of new curriculum for RN-BSN Program

Over the past 10 years since the last RN-BSN program curriculum revision, healthcare has undergone tremendous changes. Nursing roles and responsibilities, scope and standards of practice have all changed to reflect the needs of society. Nationally, 66% of all nursing graduates earn Associate Degrees in Nursing (ADNs), as opposed to BSNs. However, in New Mexico current data indicate that 85% of the recent nursing graduates were ADN-prepared (New Mexico Board of Nursing, 2012). The Future of Nursing report (Institute of Medicine, 2011) called for a more highly educated nursing force. The report recommended that 80% of the nursing workforce hold bachelor's degrees by 2020 to meet the nation's demand for health care. This newly revised curriculum will better prepare our RN-BSN graduates to assess, plan, implement and evaluate nursing interventions for changing communities and health care systems, and to advocate for policy change on a local and state-wide level.

The RN-BSN program is part of the Undergraduate Nursing Program at the College of Nursing, designed specifically for RNs with previously earned associate's degree wishing to pursue a baccalaureate degree in nursing. As this curriculum revision will replace the current RB-BSN program, no new faculty will be required. No increase in faculty workload or budgetary needs is anticipated. The CON has dedicated faculty with years of teaching experience who will teach in this exclusively on-line program, and the CON has its own IT department so no additional resources are needed for on-line support.

RN to B.S.N. Degree Completion Option for Registered Nurse (RN) Students

The RN to B.S.N. degree completion option is available primarily through online courses, with the exception of a final synthesis course. Individual arrangements are made for synthesis hours. See College of Nursing for advisement details.

All registered nurses seeking entrance into the College of Nursing must meet requirements for admission to the University and to the College of Nursing. Also needed are: a valid RN license (which must be kept current throughout enrollment) and at least 26 credit hours of college course work applicable to the B.S.N. degree.

A requirement of the College of Nursing is that all students complete ENGL 120 Composition III prior to enrolling in any upper-division nursing courses. The Acceleration Challenge Exam (ACE) II may be taken for up to 34 hours upper-division nursing course work credit.

College credit earned in associate degree nursing programs or in hospital-based diploma schools of nursing is transferable to the University, provided the original program was offered in a regionally accredited institution and the nursing program was accredited by the National League for Nursing. Such credit may be applied toward meeting the graduation requirements for a Bachelor of Science in Nursing. See Transfer of Credit.

A Plan of Studies (POS) for each student is determined at the time of enrollment into the RN-B.S.N. program. Students are expected to follow the POS throughout the program and should work with an academic advisor for any changes. Each RN student must demonstrate achievement of the outcomes expected of all College of Nursing baccalaureate students. All upper-division nursing courses, with the exception of NURS301 and 302, are 3 credit hours and are offered in seven-week blocks. Students are expected to take two courses consecutively (7 weeks each, back-to-back) every term.

Each registered nurse student is counseled individually to help clarify career goals and to plan an educational program that is of greatest benefit in meeting those goals.

Prospective registered nurse students are urged to contact the College of Nursing Student Advisement Office prior to registration. The College of Nursing supports career mobility for nurses.
