\*NOTE: Sec. 4(a) Procedure: The University Faculty shall conduct business according to Robert's Rules of Order, except as modified by Faculty vote.

The following standing rules have been approved by the Faculty: (1) May 20, 1969: "Meetings of the University Faculty shall normally be scheduled for two hours. If the agenda of a particular meeting is not concluded within two hours, a motion to adjourn shall include provision for a subsequent meeting. Alternatively, a two-thirds vote of those present could extend the meeting for another thirty minutes." (2) October 27, 1970:. No person may speak more than twice on any item, nor longer than five minutes at either time. The presiding officer will adjudge specific applications of this standing rule." (3) September 9, 1975: "Photography is permitted at faculty meetings, utilizing existing light only." (4) October 14, 1975: "Qualified members of the press are admitted to faculty meetings."
