To enhance preparedness for an international career, students in the program develop competency in a foreign language and obtain first-hand international experience in addition to regular coursework. Course Requirements: 1. Students must complete MGT 421 (International Entrepreneurship) and MGT 474 (International Finace) 2. Three elective concentration courses must be taken from among the following courses, or other appropriate courses with the approval of a faculty advisor: MGMT 420 (Management in Latin America), MGMT 422 (Seminar on Mexican Economy & Markets), MGMT 483 (International Marketing), MGMT 492 (Negotiation Strategies) and special topics courses offer in the department. 3. Students are required to complete a portion of their coursework internationally by participating in either a UNM-approved exchange with a foreign university or a UNM program. Specifically, at least two (but no more than four) of the courses applied to the concentration must be completed outside the country. Students facing economic hardship may obtain a waiver of this requirement from the faculty advisor under limited circumstances. 4. Students must complete a minimum of two upper division (i.e., 300-level and above) foreign language courses.
