BA Russian Major Study Requirements

Option A: Regular Option

Thirty credit hours of courses in Russian language and literature/culture including the following: RUSS 201–202, RUSS 301–302, RUSS 401, RUSS 402 or equivalent. Twelve credit hours culture courses in translation.

Option B: Second Major Option

Twenty-four credit hours of courses in Russian language and literature/culture including the following:

RUSS 201–202, RUSS 301–302, RUSS 401, RUSS 402 or equivalent, and six credit hours of literature/culture courses in translation
