Curriculum Workflow Document

Justification-

To streamline the General Core Curriculum and Program Core Curriculum of Business, Technology & Fine Arts Associates Degree and Certificate Programs at UNM-Valencia to promote completion. To provide relevant and updated Academic and Program Core requirements to reflect need and industry standards. To lower degree credit requirements in order to come as close to the 60 credit hour minimum as possible for Associates Degrees and 30 credit hours for Certificates.
