- EDUC 1120 will now be a requirement (not UNM GENED eligible).
- The credit hours for EDUC362 Teaching Experience I will change from 3 credits to variable credits ranging from 1-3. Teacher Candidates will take this course during the fall semester for a minimum of 2 credits.
- The credit hours for EDUC464 will change from 3 credits to variable credits ranging from 1-3. Teacher Candidates will take this course during the fall semester for 1 credit and during the spring semester for 3 credits.

Program Description

The curriculum leading to the B.S.Ed. in Secondary Education is designed for students preparing to teach in middle schools or high schools (grades 7-12). Students must meet with an academic advisor at the College of Education and Human Sciences each semester. Students should also make an appointment with a faculty advisor in Secondary Education to discuss content area course selection and career pathways.

The Secondary Education major and licensure preparation program works to develop and cultivate educators with robust cultural responsiveness in racial and cultural literacies which can contextualize the lived experiences of the young people and communities of New Mexico. The program of studies for the Secondary Education major and licensure preparation has three components:

- General Education Requirements
- Concentration-Teaching Field Requirements
- Professional Education Requirements

Students should make an appointment with an academic advisor in the College of Education and Human Sciences for admission processes. Students must apply to be admitted to the degree-granting program with a minimum of 15 credit hours, an appropriate minimum 2.75-grade point average (including transfer work), and completion of the application.

Graduation Requirements

Degree requirements:

The Bachelor of Science in Education (B.S.Ed.) in Secondary Education is a program with coursework in both academic and field areas. Therefore, students completing the B.S.Ed. in Secondary Education must complete the coursework listed below, along with requirements including 24 credit hours (12 in 300 or above courses) concentration-teaching field of their choice.

The Pre-Professional Education sequence prepares prospective teachers with foundational knowledge in adolescent development, learning theory, working with second language learners, and using technology in the classroom. These courses must be completed before starting the Professional Education sequence.

Courses in the Professional Education Sequence are required for all undergraduate students pursuing a Secondary Education major and eligibility for New Mexico Public Education (NMPED) Licensure for (grades 7-12). Students must complete the Professional Education sequence during the student teaching year. Students should meet all UNM General Education curriculum and concentration-teaching field requirements to qualify for the Professional Education sequence. However, if space is available, students within 6 credit hours of the 24 required concentration teaching credit hours may be approved to proceed into the Professional Education sequence. Students must achieve a minimum overall 2.75 GPA in all courses to advance to student teaching.

Endorsements

A student seeking NMPED licensure as a secondary education teacher (grades 7-12) must complete the curriculum in the Secondary Education concentration-teaching field that will lead to their chosen NMPED Licensure endorsements:

Curriculum in other departments and programs at UNM may lead to additional teaching endorsements with the New Mexico Public Education Department Endorsements.

The Bilingual Education endorsement is intended for individuals who are fluent in Spanish and who plan to work in a Bilingual or dual-language classroom or teach content area classes in Spanish. This endorsement program provides educators with key teaching strategies that support bilingual and multilingual students. Students should seek early advisement from a Bilingual Education Program advisor in the Department of Language, Literacy, and Socio-cultural Studies. Requirements are defined under "Minor in Bilingual Education" in the Language, Literacy, and Socio-cultural Studies: Undergraduate Program section of this Catalog.
- Endorsement in Teaching English to Speakers of Other Languages: Students may elect to pursue a K-12 endorsement in Teaching English to Speakers of Other Languages (TESOL). The TESOL endorsement is intended for individuals who will be working with English language learners in an English language classroom setting. Students should seek early advisement from a TESOL Program advisor in the Department of Language, Literacy, and Sociocultural Studies. Requirements are defined under "Minor in Teaching English to Speakers of Other Languages" in the Language, Literacy, and Socio-cultural Studies: Undergraduate Program section of this Catalog.
