### Rationale for the new course Ling 302 "Phonetic Analysis"

The proposed course is being proposed in response to changes in technology and resarch methods in our discipline. We currently teach an introductory phonetics course (Ling 303 "Introduction to Phonetics"), which focuses on articulary phonetics, and specifically on the articulation of speech sounds of English. Due to changes in technology it is now possible to teach even beginning phonetics students in more sophisticated analysis techniques, specifically acoustic analysis. This course provides in-depth instruction in acoustic analysis, which is a better preparation for those students who will pursue data-based projects in their advanced coursework. In addition, the newly proposed course differs from the existing course Ling 303 in that it has no particular focus on English, and instead exposes students to the full range of speech sounds and speech phenomena of the world's languages. Given a recent increase in faculty, the Linguistics Department will be able to continue to offer our existing course Ling 303 and, in addition, the new course.

# Impact on long-range planning

The new course fits within the long-range aims in the development of the Linguistics curriculum by streamlining the content of the Linguistics courses. At the same time, it will not negatively affect the joint teaching of phonetics between the Linguistics and SHS departments, as the existing course SHS/Ling 303 will continue to be taught and be available to students in both the Fall and the Spring.

### Detailed budget analysis

The teaching of the new course does not constitute a new budget item as no additional resources are required to implement it.

## Faculty workload implications

Due to a recent new hire, the Linguistics faculty today includes two faculty members who specialize in phonetics, Dr. Caroline Smith and Dr. Chris Koops. The workload necessary to teach the proposed course has been guaranteed since Dr. Chris Koops was hired into the Linguistics Dept. in January 2015. Since then, the capacity to teach this course has existed. The new course is being created in response to this new capacity.
