The faculty from the Counselor Education program is proposing revisions to the doctoral degree to accommodate national accreditation standards. We are requesting to remove two seminar classes COUN 620 Seminar: Consultation and COUN 620 Seminar: Advanced Multicultural Counseling and we are replacing them with COUN 646 Consultation, Program Evaluation, and Research in Counselor Education and COUN 636 Advanced Multicultural Counseling, respectively. Changing these two course numbers and titles from seminars will allow our students to take both courses without course number redundancy. Also, we are requesting to remove the non-COUN course options under our current Multicultural and Diversity Studies requirement (e.g., ANTH 537 Seminar: Southwestern Ethnology, CJ 514 Seminar in Intercultural Communication, LLSS 523 Education and Anthropology). We are requesting this change to meet accreditation standards regarding cultural issues specific to the teaching and practice of counseling in a diverse society. Also, we are requesting the removal of COUN 514 Supervision and replacing it with COUN 626 Supervision of Counseling Services. This will simply be a course number change to better reflect the doctoral level content and student population.
