Under the current catalog, graduate voice students enroll in APMS 503 Vocal Coaching for three semesters for 0 credit hours alongside APMS 501 and APMS 502 which they take for 2 credit hours each. Unfortunately, this does not allow the instructor of record for APMS 503 to submit a grade for their weekly vocal coachings at the end of the semester. We propose to submit form As and C to better reflect the current situation. We propose that graduate voice performance students enroll in APMS 501 for two semesters for 1 credit and APMS 502 Studio Instruction in the Principal Area of Concentration for two semesters for 1 credit. They will then enroll in APMS 503 Vocal Coaching for 1 credit each semester for four semesters for a total of 4 credits. The total number of credit hours will not change. Credit hours will simply be redistributed. APMS 501 Studio Instruction in the Principal Area of Concentration and APMS 502 Studio Instruction in the Principal Area of Concentration will be changed from either 2 or 4 credit hours to variable credit hours from 1 to 4. **REG OFF NOTE: see comments**
