Vice President for Athletics Report

Paul attended the NCAA Convention last week. Paul is the representative for the MW Conference and serves on the NCAA Division 1 Council. The Council voted to change requirements for a conference to hold a football championship game and the other was time demands on Student-athlete's. These topics were a big focus at the convention. The Olympic team sports do not want a limit on the number of hours that they can practice. The national SAAC Committee will push to get rid of the 20-hour a week practice rule.

A new rule was voted on that all schools must identify a Chief Medical Officer that will be with the football team during practice and games to make the medical decision whether a student-athlete is okay to play on the field. This rule will go into effect sometime in July. There was also talk about holding NCAA Championships in Las Vegas, Nevada. More to follow on that topic in April. The last major topic of discussion was regarding team travel. Can a day of travel be considered a day off? Currently, a travel day is not considered a day off. This piece of legislation was tabled for the future because there are so many unanswered questions.
