The BLT committee met on 10/12 and 11/9. Both meetings focused on UNM's 10-year financial plan. This plan serves as a roadmap and helps drive informed decision making. The major takeaways from both meetings:

- 1. UNM is expecting a slow and steady growth in all revenue sources over the next 10 years.
- 2. UNM does not have enough money in reserves according to industry standards.

- 3. Due to the passing of NM senate bill 26 (which redirects oil and gas revenues to protect against market volatility), UNM's state (core) funding should become more predictable and steadier, although UNM will not see this benefit immediately.
- 4. A slide that was presented related to benefits (which I can share) states that UNM's net income was reduced by \$69M in FY23 due to pension and health benefit cost adjustments. This liability fluctuates each year depending on the assumptions made in the valuation (such as estimated inflation rates).
