- 4. Updates. C07 "Faculty Misconduct and Progressive Discipline Policy" and A53.1 "Faculty Misconduct Review Committee" policies are moving forward to Faculty Senate and will be presented by the FS Policy Committee leadership. The Faculty Senate Operations Committee has
